As I write this today on May 31, 2020, it was 21 months ago my husband, **Lee**, was diagnosed with cancer at the back of his tongue and in his lymph nodes within the throat, at the age of 79.

He required 7 weeks of daily radiation and weekly chemotherapy. **The treatments were "brutal" and the side effects were devastating.** Knowing he would not be able to swallow as a result of the treatments, **a feeding tube was inserted into his stomach so he could get nourishment from liquid supplements.**

The **doctors were amazed he was strong enough in 5 months to remove it.** However, he still has to have all food pureed as **his throat muscles are still damaged, but healing.**

A couple of weeks into the treatments, **a very special and concerned friend, provided him with POLY-MVA, associated supplements, and an advisor to guide him in the use.**

He is now cancer free and has gained back some of his strength. Initially he was told he could lose 40 - 50 pounds. Ultimately, **he only lost 27 pounds and has gained back almost half of that.**

He returned to his part time job as an estimator for a construction company after 7 months and **continues to take the POLY-MVA on a daily basis.**

We truly believe that the **POLY-MVA strengthened his immune system to help him fight this dreadful disease.**

10-10-18

Lee was diagnosed earlier this year and his doctors immediately got him started on chemo and radiation. He was **only able to take 2 rounds of Chemo before he had to stop.** He is still doing radiation and is **on a feeding tube because of the damage and swelling from radiation** that blocked off his ability to swallow.

He still has 13 out of 35 radiation treatments left that is targeting the cancer on the back of his tongue. Lee was referred to Poly MVA by Ed Sanchez who also bought the Poly for them. I talked to Lees wife, Julie, who said **she intends to give him 8 tsp daily and CoQ10 and Four Corners.** She said Lee has really **suffered a lot from the radiation treatments.**

11-06-18

Spoke to Lee's wife, Julie, who said Lee is **still taking the Poly MVA through a feeding tube.** She is hopeful they will be getting him off of the feeding tube once the radiation treatments have ended.

5-14-19

Called and spoke to Julie. She said **Lee is doing better and seems to be slowly recovering from the negative side effects of the chemo and radiation treatments.** He had the feeding tube removed but is only able to eat and swallow

liquids and pureed foods. He is suffering from a lot of residual problems with his throat due to all of his radiation treatments.

3-26-20

Lee has been told by the Doctor that he is Cancer Free. He is still taking 4 tsps a day of Poly MVA and continues to improve from the throat damage caused by his conventional cancer treatments. Currently, Lee is still only able to eat liquid food sources.
